All learners, but particularly the learners who are at risk for not meeting Missouri Learning Standards will be given additional diagnostic assessments to provide educators with specific strengths and weaknesses of the child in specific areas. Based on the analysis of the assessments, the learner will be provided individual and/or small group instruction, in-class support, differentiated learning strategies implemented in and out of the classroom, and additional Tier I, Tier II, and Tier III data collection and actions, as needed.

This process, along with our professional learning communities, will focus on math and literacy instruction.

We have actively recruited and hired effective, experienced teachers. These teachers have shown high knowledge and instructional capabilities in the areas of literacy and math. With their background experience, and supported by our mentor program, professional learning communities, instructional coaches, and collaborative grade level teams, our teachers are encouraged to seek out resources and support for any and all areas needed to effectively deliver instruction.
